A. DECLARATION OF THE TRUST:

This Deed of Public Charitable Trust executed on this 27th day of Nov 2018, between (1. Saadat Nasir Wani S/o Nasir Aslam Wani R/o Raj Bagh, Srinagar 2. Samia W/o Nasir Aslam Wani R/o Raj Bagh, Srinagar, 3. Sarmad S/o Nasir Aslam Wani R/o Raj Bagh, Srinagar, 4. Javid Ahmad Shah S/o Nazir Ahmad Shah R/o Rajbagh, Srinagar) hereinafter called the Authors of Founders of Permanent TRUSTEE of the TRUST (which expression shall, unless excluded by or repugnant to the context, be deemed to include his executors, administrators and representatives) of the one part and

OBJECTS AND TERMS OF THE TRUST:

And whereas it is necessary to declare the objects and terms of the public charitable TRUST, being constituted under these presents.

Now this Indenture Witness these as follows:

1. THE SET APART TRUST FUND:

That, in order to effectuate the aforesaid desirous, the Trustees have deposited, a sum of Rs 20,000.00 in the account (hereinafter called the "TRUST FUND" which expression shall, include cash and any other property or investment of any kind whatsoever into which the same or any other part thereof might be converted, invested or varied from time to time or which may be acquired by the TRUSTEE or may come to their hands by virtue of these Presents or by operation of law or otherwise howsoever in relation to these presents) and the Trustees shall hold and stand possessed of the same upon the TRUST subject to the Powers, Provisions, Agreements and Declarations hereinafter contained.

2. BLESSED NAME OF THE TRUST

3. DESCRIPTION OF TRUSTEES

- A) Chairman (Saadat Nasir Wani)
- B) General Secretary (Sarmad)
- C) Treasurer (Samia)
- D) Member (Javid Ahmad Shah)

4. OBJECTS:

1. To establish, maintain or grant Aid to Homes for the Aged, Orphanages or other Establishments for the relief and help to the poor needy and destitute people. Orphans, Widows and aged persons.
2. To Establish and Develop Institutions for the physically handicapped and Disabled or Mentally Retarded Persons and to provide them Education, food Clothing or other help.
3. To Grant Relief and Assistance to the needy victims during Natural Calamities such as Famine, Earth Quake, Flood, Fire Pestilence, etc., and to raise funds to give Donations and other Assistance to Institutions, Establishments or persons engaged in such Relief Work;
4. That the Objects for which this TRUST is established are: To Construct, Repair and Manage the Cemeteries and Burial Grounds, Mosques, Temples, Gurudwara and Churches.
5. To work for the social, economic upliftment of Woman and Children by way of providing skills such as Typing, cutting, stitching, painting, and computer designing.
6. To provide, promote and extend computer education, organize sports activities, debates and cultural programs.
7. To launch a sustained campaign against Drug Abuse and preservation of environment.
8. To launch health awareness program and blood donation camps and health camps.

B. STATUS OF THE TRUST FUND

- a) That the TRUST Fund may be augmented by the income from the initial fund and also by Donations and other Contributions from time to time.
- b) That the TRUST Fund shall not be applied for any purpose other than those specified in point 'E' herein.

C. THE TRUST ACCOUNTS

That the Trustees shall always maintain proper Accounts and correspondence of the TRUST which shall be kept at the office of the TRUST and shall be run and maintained by the chairman of the trust

D. POWERS AND DUTIES OF THE TRUSTEES

That for the furtherance of the Objects of the TRUST, the Trustees shall have the following powers:

- i. To accept any Donation, Contribution, Grant or Subscription in Cash or in kind, from any person(s), Body of persons or TRUST, with or without conditions.
- ii. To apply the whole or any part of the Income of the TRUST or the TRUST Fund or Accumulations thereof, to any one or more of the Objects of the TRUST, as the Trustees may, in their Discretion Deem Fit from time to time.
- iii. To Convert and deal with the TRUST Property and or any Investments for the time being.
- iv. To Invest the TRUST Fund either in the purpose of Mortgage of Immovable Property or in shares & stocks or Debentures or other securities and Investment, or in Deposits with or Loans to any company, Bank, Firm or any other person, and to alter, vary or Transpose such investments, from time to time at the discretion of the Trustees.
- v. To Borrow or Raise or secure payments of moneys and also to lend money either with or without security.

- vi. To Sell, Dispose of, Alienate or otherwise deal with any property comprising the TRUST Fund.
- vii. To let out, Demise any Immovable Property comprised in the TRUST Fund for such period and at such Rent on such terms and conditions as the Trustees in their discretion may think fit.
- viii. To open Account in the Name of the TRUST, Trustees and or Institutions Run/Conducted by the TRUST with a Bank or Banks, to operate such Account and to give instructions to the banks and to provide for Opening and operation of such account by one or more of the Trustees or by an Agent Appointed by the Trustees.
- ix. To Adjust Settle, Compromise, Compound, refer to Arbitration all Actions, Suits, Claims, Demands and Proceedings regarding the TRUST Fund.
- x. To Appoint Constituted Attorneys or Agents and to Delegate to such Attorneys or Agents all or any of the powers vested on them under these Presents and from time to time remove such Attorneys, or Agents and To Appoint other or others in His or Their place.
- xi. To Appoint or make Provision for the Appointment of any person (including all or any of the Trustees and Committees or Administrator or managing Trustees or otherwise) for the purpose of the Administration of the TRUST in such manner and subject to such Rules and Regulations as the Trustees may prescribe and also to Appoint or provide for the Appointment of separate Trustees to hold any fund or Investments subject to the provisions of this Deed in such manner and subject to such Rules and Regulations as the Trustees may from time to time think fit.
- xii. To make, Vary, Alter or Modify Schemes, Rules and Regulations for carrying out the objects of the TRUST and for the Management of the Affairs thereof and or Running any Institutions in furtherance of the objects of the TRUST and otherwise for giving effect to the objects of the TRUST.

- xiii. To start, Abolish, Discontinue and restart any charity of ^{BU-587356} Charitable Institutions for the benefits of General Public and to Impose any conditions to any subscription or donations made by them.
- xiv. To Set apart and or Allocate the whole or a part of the Income or the corpus of the TRUST Fund or part thereof for any of the objects of the TRUST.
- xv. To join, Co-operate or Amalgamate this TRUST with other or others having Kindred or allied Objects, upon such Terms and conditions as the Trustees may in their Discretion think fit, particularly having regard to and in Conformity with the Objects and nature of this TRUST.
- xvi. To give Aid by way of donations out of the income of the corpus of the TRUST Fund or otherwise, to different Charitable Institutions, Societies, Organizations or TRUST in India which may have been established or which may hereafter be established for the like Charitable purposes mentioned in these Presents or any of them to enable such Institutions, Societies, Organisation or Trustees to Start, Maintain, or Carry out such Charitable Objects.
- xvii. To settle all Accounts and to Compromise, Compound, Abandon, or refer to Arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.
- xviii. To Borrow Moneys either on the Security of any property comprised in the TRUST Fund or otherwise for all or any of the purposes of these Presents, and it shall be Lawful for the Trustees to make such Borrowings on Payment of such Interest and otherwise on such Terms and conditions as they may in their Absolute Discretion think fit.
- xix. To Apply to the Government, Public Bodies, Urban, local, Municipal, District and other Bodies, Corporation, Companies, or Persons for and to accept Grant of money and of Aid, Donations, Gifts, Subscriptions, and other Assistance with a view to Promoting the Objects of the TRUST and to discuss

and Negotiate with the Government Departments, Public and other Bodies, Corporations, Companies or Persons, Schemes and other work and matters within the Objects of the TRUST and to Conform to any proper condition upon which such grants and other payments may be made.

- xx. To Take over or amalgamate with any other Charitable TRUST, TRUST, Association, or Institution with similar Objects.
- xxi. To Establish, Promote, Manage, Organize or maintain or to assist in Establishing, Promoting, Managing, Organizing, or maintaining any Branch of the TRUST or any other TRUST or its Branch with Objects Similar to those of this TRUST and to Promote Carry on the Affiliation or amalgamation of such other TRUST and on such Terms and Conditions as may be thought expedient.
- xxii. The author further shall function as Chairman of the trust with the confidence of other trustees and shall look after the day to day affairs of the foundation.
- xxiii. To Take over, Acquire, Manage, Control of Aid any existing Institution or Institutions having Objects either wholly or in part similar to the Objects of this TRUST and on such Terms and Conditions as may be thought expedient.
- xxiv. To Purchase or otherwise Acquire and undertake all or any part of the Property, Assets, liabilities and Engagement of any or more of the TRUSTs, Societies, Institutions or Associations with which this TRUST is authorized to Amalgamate.
- xxv. To Transfer all or any part of the Property, Assets, liabilities and Engagements of this TRUST to anyone or more of the TRUSTs, Societies, Institutions or Associations with which this TRUST is authorized to Amalgamate.
- xxvi. To Transfer and handover the TRUST to any other TRUST, Corporation, Institution, TRUST or Organisation on such Terms and Conditions as the Trustees shall in their absolute discretion think fit and proper to be held by the TRUST, Corporation, Institution, TRUST or Organisation with the Powers!

Provisions, Agreements and Declarations, appearing and contained in **BU 583358**
Presents subject to such modifications as may be necessary and consequent to
such Transfer of the TRUST Fund. The Trustees for the time being of these
Presents shall become discharged from the TRUST hereof relating to TRUST
Funds so transferred.

- xxvii. To invest the TRUST Funds in time to time in such business or securities and
in such manner as they deem fit, to alter or vary the investments so. However
that such investments shall be with in the modest specified under the
provisions of section 13(1)(a) of I.T Act 1961 and with section 11(5) of I.T.
Act 1961.

ADDITIONAL POWERS AND DUTIES OF THE TRUSTEES

08. The Trustees shall be Accountable only for such Moneys, Stocks, Shares and Funds as
shall actually come into their hands and a TRUSTEE shall not be answerable or accountable
for Neglect, Default, Act or Omission, or Commission of the other Trustees, nor of any
banker or other person with whom the TRUST Properties or any Securities may have been
Deposited or Kept.

09. The Number of the Trustees shall not be less than two and more than seven. If the Number
of the Trustees shall fall below two, the Trustees shall not, except for the purposes of filling
any Vacancy, act so long Number is below the said minimum.

10. TERM OF OFFICE OF TRUSTEES

The managing Trustees for the time being will be at liberty to Appoint Additional TRUSTEE
within the number mentioned above for such period or on such terms as to retirement and
Reappointment as the Trustees for the time being consider proper, a person shall cease to be
a TRUSTEE either:

- i. if he without leave of absence does not attend three consecutive meetings of
the Trustees or for one calendar year, whichever is longer,

- ii. if he is requested to Resign by 3/4th or as near thereto as possible of the remaining Trustees. BU 587359

11. Every TRUSTEE will be at liberty to resign on giving one month's notice of his intention to do so.

12. THE MEETINGS OF THE TRUSTEES

The Trustees may from time to time Frame Rules for the Conduct and Regulations of the meetings of Trustees, in the absence of such Regulations;

- a) Two TRUSTEE shall form a Quorum for a Meeting of the Trustees.
- b) All matters will be decided mutually by the Trustees.
- c) Resolution(s) passed without any Meeting of the Trustees but by Circulation thereof and effectual as Resolution duly passed at a Meeting of Trustees.

13. The Trustees shall have the Power to Determine in case of doubt whether any Moneys or Property shall for the purpose of the Charity be considered as Capital Income and whether out of Income or Capital any Expenses or outgoings ought to be Paid or Borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorize the Trustees to spend the Income or Corpus of the TRUST for any purpose not Authorized by these Presents.

14. ACCOUNTING YEAR:

The Accounting year of, the TRUST shall be the Financial year Ending on 31st March of every year.

15. The TRUST and the TRUST Funds shall be and Irrevocable for all times.

16. Registered Office of the TRUST the Office of the TRUST shall be situated at (place name) unless changed by the Trustees by two thirds majority at (provided address)
